The Board voted to remove the restrictive probation in the sport of basketball that was initially placed on Scotts Hill High School, which means they will now be allowed to participate in the basketball playoffs this year. The basketball program will remain on probation for the remainder of the 2019-20 school year.

The Board voted to remove the restrictive probation in the sport of basketball that was initially placed on Melrose High School, which means they will now be allowed to participate in the basketball playoffs this year. The basketball program will remain on probation for the remainder of the 2019-20 school year.

The change is:

A primary station is defined as one that has broadcast 51% of the regular season games of the school playing in the game and has a primary service area signal (60 dbu or 2.0 mV/m which encompasses the location of the school.

28. Skyuka Hall High School Requests TSSAA Membership

Skyuka Hall High School is a private school in Hamilton County. It has been in existence for six years and is a Category 3 school accredited by SAIS and TAIS. Their total 9-12 enrollment is approximately 50 students. If approved, they plan to participate in all sports sanctioned by TSSAA except football, tennis, and wrestling. If approved, they will compete in Division II, Class A (East Region), District 2 in baseball, basketball, cross country, golf, soccer, softball, track and field, and girls' volleyball. They will compete in the East Region in bowling.
