- 1. Roll Call
- 2. Approved Minutes of Last Meeting
- 3. The Board voted to give the state office staff permission to conduct the draw for the State Wrestling Tournament.
- 4. Heard review of the 2021 Regional Meetings
- 5. Heard review of 2021 Fall Sports state tournament events in golf, volleyball, girls' soccer, cross country, and cheer/dance championships. An update regarding the upcoming 2021 BlueCross Bowl was given as well.
- 6. Voted that the higher seeded team will host the first round of the Region basketball tournaments and the semifinals and finals will be at a central site. If four teams from the same district advance to the semifinals in the Region tournament, the tournament may be relocated to a site in their district.
- 7. Approved Membership Contracts for 2021-2022
- 8. Voted to not allow schools to participate in postseason competition until any outstanding fines or membership dues are paid.
- 10. Heard update from TSSAA Sports Medicine Advisory Committee
- 11. Heard update regarding the TMSAA Cross Country Championships
- 12. Heard update regarding the InsideOut Initiative
- 13. Medical District High School was approved for TSSAA Membership. They currently has 78 ninth graders and they plan to add a grade each year. They are under the Shelby County Board of Education. They plan to request a cooperative agreement with Manassas High School in all sanctioned sports.
- 14. Voted to table Arlington High School's appeal of girls' basketball sanctions until the February Board of Control meeting.
- 15. Approved Clarksville Academy's request to form a Co-op with Kenwood High School in soccer.
- 16. Appeal of suspension of registration for official Kevin Massengale was moved to the February meeting.

- 17. Voted to table the proposed change to the regional and sectional formats in baseball and softball tournaments from Bartlett High School and the TBCA. The proposal is that the region tournament would be a two-day, four team, double elimination tournament. The sectional would become a best two out of three games series.
- 18. Approved Tennessee School for the Blind's requests for Co-op exception in wrestling to allow 8th graders to participate.
- 19. The Board voted to ask Oakhaven High School to report back to the state office regarding the completion of the initiatives and community service they have put in place after the football incident that they were penalized for. This will be reviewed and voted on at the June Board of Control meeting.
- 20. Voted to table the request for membership by Providence Academy in Johnson City until the next meeting in February.
- 21. Denied the appeal of suspension of registration for official David Wray. Mr. Wray may further appeal after pending legal matters are finalized.
