1. Roll Call
2. Approved Minutes of Last Meeting
3. Voted to elect Mike Reed as President
Voted to elect Greg McCullough as Vice-President
4. Reviewed the 2022 BlueCross Bowl Team Allotment Report
5. Reviewed the Financial Report of the 2023 State Bowling Tournament
6. Reviewed the Financial Report of the 2022 TSSAA Hall of Champions Games and voted to give the state office permission in making decisions regarding whether schools can participate in future Hall of Champions games based on late submissions of financial reports.
7. Cross Country Postseason Qualifying Procedures. Voted to move Bolton, Brighton, Covington, Fayette-Ware, Lakeland Prep, and Millington Central from Region 7 to Region 8 in the sport of cross country for the next two years.
8. Board discussed the feasibility of the gradual implementation of a shot clock in basketball. Voted to allow the Basketball Coaches Association to use a shot clock during 2023 summer camps on an experimental basis in order to gather data. Asked the state office to survey school administrators and school systems.
9. The Board of Control set maximum fees for Assigning Officers.
10. Denied Clarkrange High School's appeal regarding disciplinary action taken due to an unsportsmanlike incident that occurred during the boys' basketball contest against Monterey High School on January 6, 2023.
11. Denied Monterey High School's appeal regarding disciplinary action taken due to an unsportsmanlike incident that occurred during the boys' basketball contest against Monterey High School on January 6, 2023.
12. Discussed possible mandatory disciplinary action for fan behavior.
13. Approved the 2023-2024 BlueCross Bowl Contract for the games to be held at Finley Stadium in Chattanooga in 2023 and 2024.
14. Discussed 2023 Basketball Championships
15. Voted to remove the current policy which places a \$250 fine on schools who are wearing illegal uniforms in soccer and football.
16. Board discussed procedures for determining region basketball tournament sites.

17. Approved the football playoff brackets for DI and DII for the next two years.
18. Denied Clinch High School's classification appeal to move from District 1-A to District 2-A.
19. Approved the financial report guidelines for Division I Regional and Sectional Baseball.
20. Denied Franklin County High School's request to host Winchester Christian Academy in a co-op for the sports of track and field and boys' soccer, while maintaining their current co-op with Huntland High School in those sports.
21. Approved J. Frank White Academy's Request for TSSAA Membership for the 2023-24 School Year. It is an independent school in Claiborne County with 65 students in grades 9-12. They plan to participate in basketball, cross country, track and field, golf, tennis, soccer, and girls' soccer and will be placed in DII-A, East Region, District 1. The school will be an affiliate member for the 2023-24 school year due to previously being a member of TSSAA.
